ORDINANCE NO. 1

**AN ORDINANCE OF THE EVANS CITY SEVEN FIELDS REGIONAL POLICE COMMISSION,
BUTLER COUNTY, PENNSYLVANIA ADOPTING THE MASTER PLAN AND TRUST, EFFECTIVE
JANUARY 1, 2021 AND THE ACCOMPANYING JOINDER AGREEMENT, WHICH DOCUMENTS
TOGETHER SHALL CONSTITUTE THE RETIREMENT PLAN KNOWN AS THE EVANS CITY
SEVEN FIELDS REGIONAL POLICE PENSION PLAN**

WHEREAS, the Evans City Borough, on December 1, 1952, established a retirement plan for certain of its employees known as the Borough of Evans City Police Pension Plan which subsequently regionalized with the Borough of Seven Fields to form a regional police commission known as the Evans City Seven Fields Regional Police Commission (the "Commission"); and

WHEREAS, the Evens City Seven Fields Regional Police Commission (the "Employer"), continued the former Borough of Evans City Police Pension Plan and subsequently restated the retirement plan for certain of the Commission's employees known as the Evans City Seven Fields Regional Police Pension Plan (the "Plan"); and

WHEREAS, this ordinance specifically replaces all other ordinances or parts of ordinances that established the provisions of the former Borough of Evans City Police Pension Plan; and

WHEREAS, the Employer now desires to adopt the Master Plan and Trust currently administered by the Pennsylvania State Association of Boroughs Municipal Retirement Trust (the "PSAB Municipal Retirement Trust"), effective as of January 1, 2021; and

WHEREAS, in accordance with such purpose, the Employer hereby adopts the PSAB Municipal Retirement Trust and the accompanying joinder agreement, which documents together shall constitute the retirement plan known as the Evans City Seven Fields Regional Police Pension Plan (the "Plan"); and

WHEREAS, said Plan shall be deemed to be a continuation of and a successor to the Prior Plan; and

NOW, THEREFORE, BE IT ORDAINED AND ENACTED, that, effective as of January 1, 2021, the accompanying joinder agreement and the terms of the Pennsylvania State Association of Boroughs Municipal Retirement Trust are hereby adopted by the Employer, to be known as the Evans City Seven Fields Regional Police Pension Plan; and

FURTHER ORDAINED, that said Plan shall be deemed to be a successor to and a continuation of the Prior Plan;




