

## Evans City/Seven Fields Regional Police

The Evans City/Seven Fields Regional Police Commission is currently seeking qualified candidates for **part-time police officer** positions. The Evans City/Seven Fields Regional Police Department is comprised of 5 full-time officers and 7 part-time officers and is governed by a 6 member regional police commission. The police department provides 24-hour police protection to the communities of Evans City (pop.1,833) & Seven Fields (pop. 2,900), patrols 30 combined miles of roads, and security to 100 businesses. The police department prides itself on providing the highest level of public safety services with a heavy emphasis on proactive community policing and motor vehicle enforcement.

Applicants must be **ACT 120 certified**, possess a minimum of an associate's degree in the Criminal Justice Field or the equivalent combination of education and employment experience from which comparable knowledge and abilities of four years' relevant experience in verifiable police patrol and investigation, be 21 years of age, and possess a valid Pennsylvania Driver's License. Candidates should also possess experience with computer software; including Microsoft Word Office; excellent communication skills; and an understanding of diverse populations. Preference will be given to applicants who have knowledge of Commonwealth criminal and traffic laws, rules and regulations; Municipal Police Officers Education and Training Commission; All Candidates must also commit to working a minimum of 140 hours per month and shifts. Candidates should possess exceptional moral character, strong work ethic, and pass pre-employment screenings.

**ADDITIONAL MINIMUM ENTRANCE QUALIFICATIONS AT THE TIME OF APPLICATION, AN APPLICANT MUST:**

1. Be a citizen of the United States.
2. Have at least 20/40 vision in each eye, correctable to 20/20 vision.
3. Have normal hearing in each ear.
4. Never have been convicted of:
  - a. a felony
  - b. operating under the influence of intoxicating liquor or drugs
  - c. two moving violations within the 24 months previous to application
  - d. reckless driving offense
5. Not have been suspended, demoted, discharged or asked to resign from a police position as the result of disciplinary action or because of criminal conduct.
6. Never had operator's license suspended, revoked or denied.
7. Must be physically fit and live within 20 air miles.
8. **Applicants must be ACT 120 certified by the Commonwealth of Pennsylvania through the Municipal Police Officers' Education and Training Commission (MPOETC).**
